About the Event – IMME 2022



The mining industry in India is one of the core industries, which serves as the primary input materials provider for many core sectors. The significance of mining in a nation like ours could be attributed to our high dependence on thermal energy, about 72% of energy requirement in the country is fulfilled through thermal power generation. Geographically India is endowed with a vast variety of resources raging across metallic, non-metallic, fuel and atomic minerals and has great exploration potential.

Currently, India stands tall as the world's second-largest coal and steel producer. It is also the 5th largest nation in terms of existing coal deposits. India is home to 1,531 operating mines and produces 95 minerals, which include 4 fuels, 10 metallic, 23 non-metallic, 3 atomic and 55 minor minerals. In FY 2021-22, coal production in India stood at 777.31 MT (provisional) with a growth of 8.55%. In FY22, mineral production is estimated at Rs.190,392 crore (US\$ 24.95 billion). However, India has underutilized mineral production capacity owing to the substantial mineral imports into the country.

Under the National Mineral Policy 2019 (NMP), the government envisages an effective, meaningful, and implementable policy to bring further transparency, better regulation & enforcement, balanced social and economic growth as well as sustainable mining practices. The NMP 2019 focuses on the Government's Make in India initiative and gender sensitivity in terms of its vision.

Against this backdrop, CII is organizing the 16th edition of the two-day Global Mining Summit & four-day long International Mining Machinery at Kolkata, 16-19 November 2022. The GMS is a signature event of the CII and is aimed at highlighting the growth and emerging trends in the Indian mining sector. The theme for this year's Global Mining Summit is "Role of Minerals in Shaping a Sustainable Future".


